All voted in favor to pass the motion to amend the motion on the floor.

Then all vote in favor to the amended motion. So \$500 will be fore ESA Race Day sponsorship and balance will be evenly distributed for IC Challenge registration/donation for those attending IC Convention.

There was also some further discussion about how to better distribute funds in a timely fashion. Diane Vanusek is going to put something together for the April Membership meeting and/or Convention.
